

ORDINANCE NO. 2012- 12

**AN ORDINANCE REGARDING AMENDING THE SCHEDULE OF RATES AND CHARGES COLLECTED BY THE CITY OF RISING SUN, INDIANA, FROM THE OWNERS OF PROPERTY SERVED BY THE WATERWORKS OF SAID CITY, AND OTHER MATTERS CONNECTED THEREWITH**

WHEREAS, the City of Rising Sun, Indiana ("City") has heretofore constructed, owns and has in operation a municipal waterworks, by and through the Rising Sun Utility Service Board ("Utility Board"); and

WHEREAS, the Ordinance of the City codified as §53.24 ("Ordinance"), as amended by Ordinance No. 2004-11 (collectively, "Rate Ordinance") fixed and established monthly water charges to be collected by the City from the owners of property served by the City's waterworks; and

WHEREAS, an examination of the existing schedule of rates and charges heretofore fixed by ordinances of the City has revealed that the schedule is insufficient to provide the revenues needed to pay for operating expenses, replacements and improvements; and, therefore, it is necessary to increase the rates and charges of the waterworks over a five year period to provide sufficient monies; and

WHEREAS, the Utility Service Board of the City has found that there exists a need for amending the schedule of rates and charges and has provided the Common Council of the City of Rising Sun, Indiana with a resolution to that effect; and

WHEREAS, the City has received a report from its financial advisors, O.W. Krohn & Associates, supporting the additional rates established herein;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF RISING SUN, INDIANA, THAT;

Section 1. The water rates and charges shall consist of a base service charge plus a flow rate which is based on the quantity of water used on or in the property or premises subject to such rates and charges as the same may be measured by the water meter there in use, except as otherwise provided in this ordinance. Water flow rates, based upon the amount of water used, shall be as follows:

Section 2. In all other respects, the Rate Ordinance shall remain in full force and effect.


Section 3. Prior Ordinances. All ordinances and/or parts of ordinances in conflict herewith are hereby repealed.

If any section, sub-section, sentence, clause, phrase or portion of this ordinance shall for any reason be held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not effect the validity of the remaining portions thereunder.

Section 5. Effective Date. This ordinance shall be in full force and effect from and after its passed by the Common Council, its approval by the Mayor, and completion of any notice requirements, all in the manner as provided by law.
