PART 1 - GENERAL TIME AND PLACE OF BIDS

Bids: Notice is hereby given that sealed bids for various items of work for the construction of the new library for the Ohio County Public Library, Rising Sun, Indiana, shall be received by the Library Board, until 4:00 p.m. local time, January 17, 2006, at the Ohio County Public Library, Rising Sun, Indiana. Bids received after 4:00 p.m. local time (Eastern Time Zone) shall be returned unopened.

Informalities: The Owner reserves the right to accept or reject any bid or waive any informality or error in bidding for a period of 60 days after bid opening date.

METHOD OF BIDDING
Single Proposal including general construction. Owner: The Owner shall be the Ohio County Public Library. TAX EXEMPTIONS (Legal Entities):

Contract price will be based upon a complete exemption of Indiana State Sales Tax, and if later determined that a tax must be paid by Owner, contract price will be adjusted to reflect this liability of Owner. Owner will furnish copies of tax exemption certificates to all contractors.

PREPARATION AND SUBMISSION OF BIDS
Bids received after such time will be returned unopened. Bids may be withdrawn prior to such time, but no bids shall be withdrawn for a period of 60 days thereafter.

Bids shall be addressed to the Ohio County Public Library, Rising Sun, Indiana, and completely and properly executed on the Bid Form 96 (revised 1987) and Standard Questionnaires and Financial Statements for Bidders, Indiana State Form No. 96-A, as prescribed by the State Board of Accounts, giving financial data as recent as possible and in no event more than ninety (90) days old. No Assets outside the USA shall be included in financial statements.

Each Bid shall be accompanied by an executed Non-Collusion Affidavit, an executed Bid Bond in the minimum amount of five percent (5%) of the Bid and such other documents required by the instructions to Bidders. Bid Bond may be a certified or cashier's check payable to the Ohio County Public Library, or an acceptable bidder's bond.

The Owner may make such investigations as deemed necessary to determine the ability of the Bidder to perform the work and the Bidder shall furnish to the Owner all such information and data for this purpose as the Owner may request.

Each Bidder is responsible for inspecting the Project site(s) and for reading and being thoroughly familiar with the Contract Documents and specifications. The failure or omissions of any Bidder to do any of the foregoing shall in no way
