**WHEREAS**, the City of Rising Sun wishes to clarify that said lap tops and broadband service shall be used for communications including but not limited to City business;


**WHEREAS**, the City of Rising Sun also should approve that said lap tops will be available for purchase upon termination of office or term by the aforesaid parties.






