

RESOLUTION 2012- 8

**An Amending Resolution to Resolution 2011- 14 regarding Computer/Laptops and/or Broadband Service provided to Elected Officials and Appointed Employees of the City of Rising Sun.**

**WHEREAS**, the current Resolution 2011-14 regulating the use of Computer/Laptops and/or Broadband Service provided to Elected Officials and Appointed Employees of the City of Rising Sun does not adequately address of the use of the Equipment and Service;

**WHEREAS**, the City of Rising Sun has provided Elected Officials and Appointed Employees of the City of Rising Sun with Computer/Laptops and/or Broadband Service

**WHEREAS**, the City of Rising Sun feels that the providing of said Equipment and Service is beneficial to said recipients as well as City staff;

**WHEREAS**, the City of Rising Sun wishes to clarify that said Equipment and Service shall be used for communications in a manner related to the functions and purposes of the governmental unit;

**WHEREAS**, the City of Rising Sun is responsible for compliance with all rules, regulations, guidelines, and directives of the IRS and the Indiana Dept of Revenue and will report this as a fringe benefit if directed by the IRS and/or the Indiana Dept of Revenue;


**WHEREAS**, the City of Rising Sun also should approve that said lap tops will be available for purchase upon termination of office or term by the aforesaid parties.

**NOW, THEREFORE REPEAL RESOLUTION 2011-14 AND BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF RISING SUN, OHIO COUNTY, INDIANA that:**

1. Elected Officials and Appointed Employees shall use the Computers/Laptops and/or Broadband Service provided by the City for communications in a manner related to the functions and purposes of the governmental unit;
2. That upon termination of those individuals from their respective office or term, they shall be able to purchase said Equipment for a price determined by Council at the time of the request to do so; otherwise, all such Equipment shall be returned to the City.
3. Usage of the equipment and service will be reported as a fringe benefit to the Elected Official or Appointed Employee if directed by the IRS and/or Indiana Dept of Revenue.




