

RESOLUTION 2011- 15

**AN EMERGENCY RESOLUTION PROVIDING FOR THE TRANSFER OF APPROPRIATIONS FOR SEVERAL DEPARTMENTS OF THE CITY OF RISING SUN, INDIANA, FOR THE YEAR 2011, AS REQUIRED BY THE DEPARTMENT HEADS AND FORWARDED TO THE COMMON COUNCIL FOR THEIR ACTION AND PASSAGE PURSUANT TO IC 6-1.1-18-6**

**WHEREAS,** Certain extraordinary conditions have developed since the adoption of the existing annual budget for the year 2011 and it is now necessary to transfer appropriations into different categories than was appropriated in the annual budget for the various functions of the several departments to meet the emergencies.

**NOW, THEREFORE, BE IT RESOLVED** BY THE COMMON COUNCIL OF THE CITY OF RISING SUN, INDIANA THAT:

**SECTION 1.** For that expenses of the City Government, the following appropriations are hereby transferred and set apart out of the funds hereinafter named for the purposes specified, subject to the laws governing the same, such funds herein transferred unless otherwise stipulated by law.



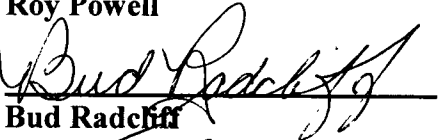


