**Call to order/Pledge**

The meeting was called to order with the Pledge of Allegiance led by Mayor Marksberry. All of Council was present except Councilman Graves and Councilman Padgett.

**Fairground Community Building**

Mike Northcutt, presented a bid tabulation sheet to Mayor Marksberry and City Council for review. See Attached Exhibit A. There was discussion that there were four bids. All bidders were present at the opening along with Attorney Siekman and all bids were in proper format. Northcutt, on behalf of the Task Force and based on information received from the Engineer for the project, made recommendation to accept Fletcher Construction as lowest responsive and responsible bidder in the amount of \$267,000. After further discussion a motion was made by Councilman Powell to accept the alternate bid from Fletcher Construction in the amount of \$267,000 as the lowest responsive and responsible bidder for the construction of the Community Building/Exhibit Hall at the New Fairgrounds Park, 2<sup>nd</sup> by Councilman Slack; motion carried 3-0.

Mike also presented information to Council regarding gutters and lighting at the new Fairgrounds Park. See attached Exhibit B.

**Regarding electrical supplies for electrical fixtures for the barn and show arena:**

Cost is for purchasing materials not installing. After discussion a motion was made by Councilman Radcliff to approve the low quote of D & J Electric, 2<sup>nd</sup> by Councilman Powell; motion carried 3-0.

After discussion a motion was made by Councilman Slack to approve the low quote of Swanson Construction, 2<sup>nd</sup> by Councilman Radcliff; motion carried 3-0.


Northcutt also informed all present that pipe had been ordered from Discount Drainage and the County Highway Department will be installing storm sewers


**Adjournment**

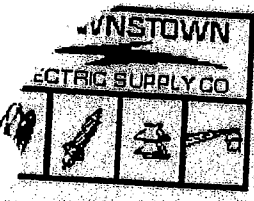
