

RESOLUTION 2010 - 9

A RESOLUTION APPROVING A TWO (2) YEAR EXTENSION
OF CONTRACT FOR COLLECTION AND DISPOSAL
OF SOLID WASTE AND RECYCLABLES
WITH RUMPKE OF INDIANA, LLC

WHEREAS, The City of Rising Sun by its common council has previously entered into an agreement for the Collection and Disposal of Solid Waste and Recyclables with Rumpke of Indiana, LLC, on the 11th day of October, 2007, (the "Agreement").

WHEREAS, the said Agreement expires on September 30, 2010 and it is in the best interests of the Citizens of Rising Sun to extend and continue said Agreement under the option to extend which is contained therein;

It is agreed that the said Agreement shall be extended for an additional term of two (2) years, commencing upon the expiration of the original term of the agreement and expiring on September 20, 2012.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF RISING SUN, INDIANA THAT:

1. The Mayor of the City of Rising Sun is hereby given the authority to enter into a two (2) year written extension of the agreement for the Collection and Disposal of Solid Waste and Recyclables with Rumpke of Indiana, LLC
2. This extension shall be on the same terms and conditions as contained in the original Agreement and as if set forth herein excepting that:
 1. Compensation for services shall be billed upon the current rate in in effect. Specifically, the Contractor shall invoice the City on a monthly basis as follows:

\$10.30 Per Unit - Solid Waste
\$3.00 per unit - Recycling
 2. The monthly invoice shall be based on 980 units.

**EXTENSION OF CONTRACT FOR COLLECTION
AND DISPOSAL OF SOLID WASTE AND RECYCLABLES**

THIS EXTENSION AGREEMENT made by and between the **City of Rising Sun, Indiana**, (the "City") and **Rumpke of Indiana, LLC** (the "Contractor") in respect of an existing agreement between the parties dated the 11th day of October, 2007, (the "Agreement").

Whereas the said Agreement expires on September 30, 2010 and the parties desire to extend and continue said Agreement under the option to extend which is contained therein;

It is agreed that the said Agreement shall be extended for an additional term of two (2) years, commencing upon the expiration of the original term of the agreement and expiring on September 20, 2012.

This extension shall be on the same terms and conditions as contained in the original Agreement and as if set forth herein excepting that:

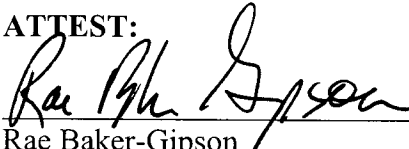
1. Compensation for services shall be billed upon the current rate in in effect. Specifically, the Contractor shall invoice the City on a monthly basis as follows:

2. The monthly invoice shall be based on 980 units.

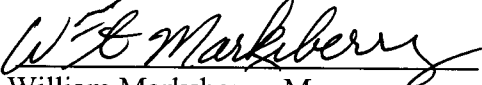
