NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Rising Sun, Indiana, that


Section 1. Said Trey Clifton's tenure as a Commissioner on the IMPA Board of Commissioners is hereby terminated.

Section 2. Sue Bovard is hereby appointed as a Commissioner on said IMPA Board of Commissioners of IMPA.


Section 4. This resolution shall be in full force and effect from and after its passage in accordance with the law.


