

AN ORDINANCE TO AMEND THE BUILDING INSPECTION FEE RATE SCHEDULE
OF THE CITY OF RISING SUN, INDIANABE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF RISING SUN,
INDIANA:WHEREAS, The Plan Commission of the City of Rising Sun has recommended an amendment
to the City of Rising Sun's Building Inspection Fee Rate Schedule; andWHEREAS, because of increasing cost in the operation of the City's Building Inspections, it is
necessary to increase fees charged by the City for such inspections; andTHEREFORE, THE BUILDING INSPECTION FEE RATE SCHEDULE OF THE CITY OF
RISING SUN, INDIANA, BEING A SEPARATE ORDINANCE AND PART OF THE
MUNICIPAL CODE OF THE CITY OF RISING SUN, INDIANA, IS HEREBY AMENDED
AS FOLLOWS:SECTION 1. Building Inspection Fee Rate Schedule

Multi-family dwellings, hotels, Motels (each unit) (plus five cents (.05) per square foot of the floor area) (each building)	\$ 100.00/unit
Business, commercial, public (plus five cents (.05) per square foot of the floor area) (each building)	\$ 150.00
Educational, institutional, church (plus five cents (.05) per square foot of the total floor area)	\$ 150.00
Industrial, warehouse, bulk (plus five cents (.05) per square foot of the total floor area) (each building)	\$ 150.00
<u>Accessory Building</u>	
Pole Barn and detached Garage (unfinished)	\$ 50.00
(finished)	\$ 75.00

Small storage building	no permit
Temporary Structures (job trailer)	no permit
Additions/Alterations (all occupancies)	\$ 50.00

0-120 sq. ft.	no permit
over 120 sq. ft.	\$ 20.00
Swimming pool (residential use)	
inground pool	\$ 30.00
above ground pool	\$ 15.00
Electrical upgrade	\$ 25.00
